ARTICLE 3 ADMISSION REQUIREMENTS

There are no limits of age or citizenship for applications to the Research Doctorate. Applicants must:

A) hold a degree (D.M. 509/99) or a specialist degree/master (second cycle degree D.M. 509/99 and D.M. 270/04) or an equivalent qualification from a foreign university;

B) pay the contribution of €50 for each application presented. The payment must be made by **26th October 2011**.

C) present a declaration of equivalence if the candidate holds a foreign qualification. Should the candidate not have a declaration of equivalence, they can apply to the Teaching Committee for such a declaration, purely for the purpose of admission to the Doctorate.

In order to allow the Teaching Committee to issue a declaration of equivalence the candidate must present:

1) the degree certificate, translated, sworn and accompanied by a dichiarazione di valore.

On penalty of exclusion, the documents set out in point 1) must be attached to the application online.

Should the documents set out in point 1) be in a foreign language, they must be translated (except for those in English and French) and sworn by the competent Italian diplomatic representatives or consulates abroad, in accordance with current legislation in the country in question.

Should it not be possible to present a dichiarazione di valore, the candidate must, on penalty of exclusion, attach to the online application a personal, signed declaration in which they agree to send the aforementioned documents as soon as possible, using Enclosure B.

Following admission, the dichiarazione di valore must be sent before the official start of the course (January 1st 2012), on penalty of exclusion from the Doctorate.

Candidates who have a degree from Germany or Austria need not present the declaration of equivalence.

The results of the declaration of equivalence by the Teaching Committee will be published, at least two days prior to the date of the first examination on the websites

D) It is possible to take part in the competitive public examination even if the candidate does not yet hold a degree when presenting the application, providing they will graduate before the date of the first examination.

Candidates who will graduate abroad must use Enclosure C when presenting the online application.

These candidates must then send to the Servizio Ricerca e Formazione Avanzata - Divisione Ricerca e Relazioni Internazionali – a declaration of graduation (Enclosure B) prior to the date of the first examination.

Candidates who graduate in Italy and take part in the selection procedure by assessment of qualifications must send to the Servizio Ricerca e Formazione Avanzata - Divisione Ricerca e Relazioni Internazionali – a declaration of graduation (Enclosure D) prior to the date of the first examination.

Applicants who already hold the academic title of Research Doctor, can only apply for places without study grant.

For each application sent the candidate must pay a contribution of €50.00 according to the conditions set out in the online application form.

ARTICLE 5 ADMISSIONS BY QUALIFICATIONS FOR CANDIDATES RESIDENT ABROAD

Candidates resident abroad can apply for reserved places, where foreseen by the individual Doctorates, on the basis of assessment of qualifications in the disciplinary area of the Doctorate.

The above candidates are exonerated from the payment of the contribution of €50.00 for participation in the competitive public examination, and must send their application using only the online procedure found on the websites:

They must also attach to the online application the following documents:

1. degree certificate, translated, sworn and with dichiarazione di valore if issued by a foreign authority, together with a list of the examinations taken;
2. curriculum vitae;
3. at least two letters of reference;
4. a research project chosen from the titles/areas proposed by the Doctorate
5. list
6. two preferences from the titles/areas of the projects proposed. These preferences shall not be binding for the Teaching Committee

In the case of applications for more than one Doctorate, the above documents must be enclosed with each application using the online procedure.

Should the documents set out in point 1) be in a foreign language, they must be translated (except for those in English and French) and sworn by the competent Italian diplomatic representatives or consulates abroad, in accordance with current legislation in the country in question.

The documents set out in points 2 and 3 do not require a sworn translation, but they must be produced in one of the following languages: Italian, English, and French.

It is possible to take part in the competitive public examination even if the candidate does not yet hold a degree when presenting the application, providing they will graduate before the date of the first examination. See Article 3, paragraph D, above.

Should the places reserved for candidates taking part in the competition by assessment of qualifications not be assigned, they will be added to the ordinary classification of the Doctorate.

Should the candidate who intends to apply for selection by assessment of qualifications, despite the reserved places, intend to take part in the ordinary examination, they must follow the procedure set out in Article 7 below. It is not possible to apply for both procedures.

In evaluating the candidates each Commission can award a maximum of 60 points, divided according to criteria decided by the Commission itself.

The assessment of qualifications is considered valid if the candidate attains an evaluation of at least 20/60.

ARTICLE 6 ENROLMENT FOR CANDIDATES WHO ARE ASSIGNED PLACES RESERVED FOR STUDENTS RESIDENT ABROAD

On penalty of exclusion, within 5 days of publication of the ranking, candidates must confirm their enrolment using the online procedure.

Following this confirmation, the candidate must contact the Office by mail at the following address phdprogrammes@unito.it in order to complete the enrolment on the course prior to the official start of the Doctorate.

To complete the enrolment the candidate must present:

1. a certificate of equivalence, for successful candidates holding a foreign degree and who have not asked the Teaching Committee for a certificate at the time of application;
2. a passport photograph, signed on the back;
3. a photocopy of an identity document;
4. a photocopy of the tax code;
5. degree certificate and dichiarazione di valore in the original;
6. FORM A including:
 - application for enrolment in the Doctorate;
 - declaration that the candidate is not enrolled in degree courses, Italian university masters; university schools of specialisation, Doctorates organized by private institutions, in accordance with Article 17, paragraph 96, L127/1997. It is possible to attend both a specialization course in medicine and the research doctorate, in accordance with Article 19, paragraph 1, letter c) of Italian Law 240 dated December 30th 2010. In the case of joint attendance, the duration of the course is reduced by a minimum of two years. This regulation is applied to graduates in Medicine and Surgery who hold specialist training contracts in accordance with Legislative Decree N. 368 dated August 17th 1999.
7. FORM B with the bank coordinates for payment of the instalments (only for candidates who have been awarded a study grant);
8. FORM C with a declaration of any work activities. For regulations concerning compatibility with work activities, please refer to Article 25 of the Regulations on the Doctoral Schools and Research Doctorates of the University of Torino.

ARTICLE 7 ADMISSION EXAMINATION

During the written examination the candidate must indicate at least two preferences from the research projects/areas proposed by the Doctorate and published on the websites:

This choice will not be binding for the Commission.

The Commission may also ask for verification of the knowledge of the foreign languages indicated by the candidate.

The final ranking will be composed of the sum of the marks attained by the candidate during the selection procedures.

Each Commission can award a maximum of 60 point for each examination. Candidates who have passed the written examination, or the assessment of qualifications with a mark of not less than 40/60 will be admitted to the interviews. The interview will be considered successful if the candidate attains a mark of not less than 40/60.

In the case of equal merit for the assignment of the study grant, the financial situation will be evaluated, in accordance with D.P.C.M. 30/04/1997, while for the assignment of places without study grant, the youngest candidate will be assigned, in accordance with Article 3 of Italian Law N. 27 dated 15/05/1997.

Any additional study grants and apprenticeships, in accordance with Article 19, paragraph 1, subparagraph b) of Italian Law N. 240/2010 and Article 50 of D.Lgs. N. 276/2003, funded after this announcement will be published on the websites:

These study grants will be assigned in accordance with the ranking.

ARTICLE 10 JUDGING COMMISSION

The Judging Commission for admission to the Doctorates, nominated by the Rector by Rector’s Decree, is composed of three effective members and three supplementary members, chosen from the tenured University professors and researchers specialized in the disciplines relating to the scientific

areas of the courses. This Commission may be integrated with not more than two experts, also foreign, chosen from public and private research institutions.

ARTICLE 11 SUPRANUMERARY ADMISSIONS

Foreign students who have been placed in the ranking can be admitted to the Research Doctorate in supernumerary places, according to the number of places, with a limit equal to half the number of places available, rounded up, providing they hold study grants conferred on the basis of merit.

All those who have been selected under the 7th Framework Programme for Technological Research and Development or other international cooperation programmes (e.g.: Erasmus Mundus) and who hold a study grant or a research contract in the scientific disciplinary area of the Doctorate will be admitted to the Doctorate as supernumerary participants. The selection procedure will be considered completed, since it was already carried out for the European project. These candidates can present an application before the start date of the Doctorate. Enrolment is subject to approval by the Teaching Committee of the Doctorate.

ARTICLE 12 CHARACTERISTICS OF THE STUDY GRANTS

The annual amount of the study grant, except in the case of amendments to the law, is equal to € 13.638,47 and is subject to I.N.P.S. welfare contributions “gestione separata”.

The duration of the study grant is equal to the entire duration of the course.

The instalments are paid each month after the first month of the course. The study grant is increased for any periods of activity abroad by 50% for an overall period not in excess of the exact half of the duration of the course. The study grant funded by the “Fondo per il sostegno dei giovani e per favorire la mobilità degli studenti” is increased by not less than 50% for a maximum period of 12 months. Winners of study grants funded by external bodies (including the study grants mentioned in Article 1, paragraph 3) must make every effort to understand any special conditions foreseen by the agreement with the funding body.

The study grant cannot be compounded with other study grants from any source, except for those granted by national and international institutions for the integration of the doctoral students’ training with periods of study abroad.

The study grant cannot be compounded with a research grant. Anyone who has benefitted, even partially, from a Doctoral study grant is excluded from benefitting a second time, unless the previous sum has already been repaid. Study grants are not compatible with specialist training contracts, in accordance with Legislative Decree N. 368 dated August 17th 1999 and with apprenticeship contracts in accordance with Legislative Decree N. 276 dated September 10th 2003.

ARTICLE 13 RIGHTS AND OBLIGATIONS OF THE DOCTORAL STUDENTS

Students enrolled in Research Doctorates must attend and carry out all the study and research activities at the University structure, according to the instructions of the Doctorate Teaching Committee.

In accordance with Article 4, paragraph 8 of Italian Law 210 dated July 3rd 1998, doctoral students may carry out a limited amount of subsidiary and integrative teaching, except where this is prohibited by the Doctorate Teaching Committee. Teaching activities are optional, they must not compromise the research activities and do not give the right to a University post.

In accordance with Italian Law N. 4 dated 14/01/1999, candidates admitted to the Research Doctorate at the Faculty of Medicine and Surgery, on request and on approval by the structure to which the doctorate belongs, may be employed as assistants.

The PhD certificate will be issued once the student has filed the final dissertation in the University open access archive, which will guarantee its preservation and allow public consultation. The University will file the dissertation at the national libraries. For all matters concerning the Doctoral course s and the qualification, the University Regulations for Doctoral Schools and Research Doctorates at the University of Torino shall apply.

ARTICLE 14 INCOMPATIBILITY

Enrolment in a Doctoral course is incompatible with simultaneous three-year and/or specialist degree courses, Italian university masters, university specialization schools or doctoral courses, and enrolment in specialization courses organized by private institutions, qualified under Article 17, paragraph 96, Italian Law 127/1997.

On enrolment the candidate who is enrolled in more than one course must, within fifteen days, regularize their position, on penalty of exclusion.

It is possible to attend both a specialization course in medicine and the research doctorate, in accordance with Article 19, paragraph 1, letter c) of Italian Law 240 dated December 30th 2010.

In the case of joint attendance, the duration of the course is reduced by a minimum of two years. This regulation is applied to graduates in Medicine and Surgery who hold specialist training contracts in accordance with Legislative Decree N. 368 dated August 17th 1999.

The public employee who is admitted to research doctoral courses will be granted, on request and compatibly with the requirements of the administration, extraordinary leave for reasons of study for the duration of the course and will receive a study grant. In the case of admission to research doctorates without a study grant, or where the candidate renounces the study grant, the person on leave maintains the usual economic and welfare conditions from the public administration by which they are employed. The public employees who already hold the academic title of PhD and public employees who have previously been enrolled in a doctoral course for at least one academic year, while on extraordinary leave, do not have the right to benefit from these conditions.

ARTICLE 15 RETURN OF QUALIFICATIONS AND PUBLICATIONS

Should candidates renounce the doctorate and/or be excluded, anyone who has filed qualifications and/or publications must collect them at their own expense.

ARTICLE 16 ELABORATION OF PERSONAL DATA AND RIGHT OF ACCESS

In accordance with Article 13 of D. Lgs. 196/2003 candidates are informed that their personal data will be gathered by the Università degli Studi di Torino for purposes relating to the selection procedure and will be elaborated by an automatic databank also following the selection procedure, for the purpose of management of enrolment in the doctoral course. The information supplied by candidates will also be used for the purpose of institutional functions of the University of Torino within the limits set by current legislation, the regulations, and in accordance with principles of transparency, correctness, confidentiality and necessity.

In accordance with Article 4, paragraph a) of D. Lgs. 196/2003, the term 'elaboration' means any operation or set of operations carried out also without the use of electronic instruments, with regard to the gathering, the registration, organization, preservation, use, linking, blocking, communication, diffusion, cancellation and destruction of the data, even if not filed in a database.

The data collected may be communicated to other public and private subjects with the methods and within the limits of the aforementioned Legislative Decree and of the Regulations for implementation of the "Code on Matters Pertaining to the Protection of Personal Data" of the University of Torino.

It is compulsory to supply the data requested for the purposes of evaluation of the requirements, on penalty of exclusion from the selection procedure.

Candidates enjoy all the rights foreseen by Article 7 of D. Lgs. 196/2003, including the right of access to the data that concerns them, and complementary rights including the right to amend, update, complete or delete erroneous or incomplete data, or data gathered without compliance to current legislation, and the right to oppose the elaboration of the data for legitimate reasons.

These rights may be asserted against the Rector of the University of Torino, holder of the personal data.

The person responsible for the elaboration of the personal data is the Director of the Ricerca e Relazioni Internazionali of the University of Torino.

ARTICLE 17

For all matters not expressly dealt with in this announcement, refer to the University Regulations for the Doctoral Schools and the Research Doctorates of the University of Torino (D.R. N. 28 dated January 12th 2011) and to national legislation.
