



ANNEX I – SCHOOL AND DEPARTMENT RULES AND SELECTION CRITERIA FOR APPLICANTS

(v01 del 14/11/2023)

PLEASE NOTE:

**The present English version is provided for information purposes only.
In the case of conflicting meanings between the two versions, the Italian version prevails.**

The University of Turin Statute (D.R. No. 1730 of March 15, 2012) proclaims that Schools will manage International Mobility related services. So, for academic year 2024/2025, the Erasmus+ Mobility will be managed by Schools directly or Departments will manage Erasmus+ Mobility internally if they do not belong to a School. This Annex details each School or Department's specific indications concerning submitting applications, selection criteria for candidates and any other specific characteristics.

The “*Uffici Servizi per l’Internazionalizzazione di Polo*” support students interested in applying for the Erasmus+ Call for Studies academic year 2024/2025 regarding each School and/or Department's specifications.

Before applying it is compulsory to:

- **CAREFULLY read** the Call and this Annex;
- Attend one of the **orientation meetings** that the Department organises.

Students enrolled in undergraduate degree program, postgraduate degree program and PhDs from the Department of Foreign Languages and Literatures and Modern Cultures **can apply**.

1. Destinations (UP/PG)

Students can only apply for places offering the same LEVEL of study they are enrolled in, otherwise their application is invalid.

For example:

- **undergraduate degree programme** and first-level Master students can **ONLY** apply for **UG level** places;
- **Postgraduate degree programme** and **Second-level Master** students can **ONLY** apply for **PG-level** places;
- PhD students can **ONLY** apply for **Level D** destinations.

THE ONLY EXCEPTION: 3rd year undergraduate degree programme students who intend enrolling in a postgraduate degree programme at the University of Turin in academic year 2024-25 must apply for PG level destinations.

2. Certification

- **Postgraduate degree candidates must attach their undergraduate Degree certificate (or self- certification) to their application**, proving the exams and marks obtained, otherwise their application will be invalid.
- It is recommended to attach any **linguistic certifications** held to the application.

3. Choice of Destinations

Students can apply for a **maximum of two destinations**.

READ THE FOLLOWING CAREFULLY:

- further destinations chosen will not be considered;
- students can decide to apply for just one destination;
- students can **ONLY** apply for destinations pertaining to the Department of Foreign Languages and Literatures and Modern Cultures, otherwise their application will be invalid;
- **CANDIDATES MUST CONSULT the "Notes" field in Active Destinations BEFORE SUBMITTING THEIR APPLICATION** so to be aware of any specifications concerning the exchange and eligibility restrictions on certain destinations i.e. places reserved for specific



courses, double degree qualifications, specific exam requirements, etc.

4. Ranking

The **basic score** will be awarded according to criteria published in the General Call. **Extra points** (max 30 points) will be awarded, according to the following criteria:

- **up to 10 points for SIGNIFICANT language skills** related to the destination the student is applying for (based on language exams or any advanced language certification);
- **up to 20 points for consistency between the student's own courses and the Host University's Mobility programme** which the student is applying for. The score awarded will be based on the study project the student describes in the NOTES field of the application. It is therefore in the candidate's interest to fill in this field in detail for each destination, and preferably using the exchange LANGUAGE for the chosen destination. For this purpose, it will be useful:
 1. for each Mobility destination chosen to detail the reasons for the selected destination, based on objective academic aspects (students should indicate how many credits they aim to acquire during the Mobility, which Partner University courses they want to take, which exams correspond to their own courses, etc.);
 2. to present a self-certification language proficiency relevant to the Mobility, including academic achievements;
 3. to check the consistency between the exams the student intends to take abroad and the courses offered at the Partner University. Students will therefore have to search in the University Partner website for courses BEFORE submitting their Erasmus+ application. During this phase students MUST NOT contact Partner Universities.

First year undergraduate degree students not outside prescribed time will receive **up to 30 points** based on their High school leaving grade (i.e. "voto di maturità"), since they do not have any University grade registered to be used for the "base score" awarding. Therefore, in these cases the "base score" will be awarded on the following criteria:

- under 70: 0 points
- from 70 to 79: 10 points
- from 80 to 89: 20 points
- from 90 to 95: 25 points
- from 96 and upwards: 30 points

Students will be considered **eligible for Mobility**, and therefore added to the final candidate list, if they obtain an overall score (basic score + additional score) of at least **35 points out of 100**.

5. Reallocations

Vacant places will be reassigned by the Commission after the publication of the first ranking list. The Commission will assign the vacant destinations within the linguistic area and by disciplinary scientific sector. Only students eligible for a mobility will be admitted to this phase.

DEPARTMENT OF PSYCHOLOGY: PSYCHOLOGY I, II AND III AND "SUISM" I AND II DEGREE PROGRAMMES

1. How to apply

1.1. Areas of discipline ISCED

Department of Psychology students can apply for all Department destinations identified by area of discipline **ISCED 0313 – Psychology**.

Criminological and Forensic Psychology students can also apply for all Department destinations identified by area of discipline **ISCED 042 – Law**.

PhD students can apply for all **Department** of Psychology destinations identified by disciplinary area **ISCED 0313 – Psychology** with **places available for level D**.

SUISM students can apply for all Department of Psychology destinations identified by disciplinary area **ISCED 1014 – Sport**.

1.2. UG/PG/D levels

Candidates must check the available locations and that the destination of interest includes vacancies at the level corresponding to their degree program.

PLEASE NOTE: 3rd year undergraduate degree students planning to graduate before leaving and therefore wanting to do Mobility in their first year of a postgraduate degree, must apply for the **PG level**. Students CANNOT graduate during Mobility.

Students wishing to apply for Mobility in their **first year of a postgraduate degree** with restricted places, can only leave once they have enrolled, so only in the second semester. In this case, students are advised to choose destinations offering a number of monthly payments suitable to their needs (5/6 months Mobility).

1.3. Reserved destinations

Candidates should pay close attention to the "**Note - Notes**" field in each destination that the Department of Psychology offers as some destinations could be reserved for specific course programmes of the Department or SUISM. Therefore, applications from candidates not enrolled on the programs will be automatically excluded.

2. Extra points

The Department's International Mobility Committee can add extra points by applying the following criteria (**max. 30 points**):

- **10 points for motivation and training objectives** (as in the "**Dichiarazioni aggiuntive** - Additional Declarations" section of the application):
 - 3 points for motivation related to studies;
 - 3 points for motivation related to professional experience, if relevant and consistent with Degree course;
 - 3 points for motivation related to language – i.e. learning, improving local and target language;
 - 1 point for particularly deserving reasons.

N.B. Applicants are informed that if the field "**Dichiarazioni aggiuntive** - Additional Declarations" is not filled in and/or the reason for departure is not stated in any way, the Commission will assign an additional score of zero (0).



- **10 points for language skills** and stays abroad, excluding family holidays. Students should add these points to the "Note - Notes" section of the destinations selected during application. Candidates must produce their language level certificates, proving:
 - Knowledge and any language level certificates related to host country's language;
 - Knowledge and any language level certificates related to the target language;
 - Any other languages.

Candidates must check Host University language requirements before applying and they must be in possession of these requirements including any language certifications required and according to Host University deadlines.

The Italian Association of University Language Centres (AICLU) validates the following language certifications:

PLEASE NOTE: Mother tongue students of the host country's language can self-certify their language skills in the **"Note - Notes"** field of their application. However, students should also check that self-certifying language skills is sufficient for their chosen destination. Should the host institution require a language certificate, applicants and mother tongue speakers might also be required to obtain a certificate from the host location. Students should therefore consult the partner University website and/or ask for clarification from the Mobility office dealing with the agreement.

- **10 points for any professional experience** in Italy or abroad and any other experiences in **associations, sports and culture** which students should outline in the "Note - Notes" section of the destinations in their applications. Candidates must indicate clearly and in detail:
 - Length and time of experience;
 - Host institution/employer;
 - Profile description (relevance to studies).

N.B. First year undergraduate degree students will be awarded **up to 100** points as follows:

- **10 points for High School Diploma grade** as follows:
 - **5 points** for leaving certificate grade of less than 70/100 (or less than 42/60);
 - **10 points** for leaving certificate grade equal to or above 70/100 (equal to or above 42/60).
- **30 points for motivation and training objectives** (as in the "Dichiarazioni aggiuntive - Additional Declarations" section of the application).

N.B. Applicants are informed that if the field **"Dichiarazioni aggiuntive - Additional**



Declarations" is not filled in and/or the reason for departure is not stated in any way, the Commission will assign an additional score of zero (0).

- **30 points** for **language skills** and stays abroad, excluding family holidays. Students should add these points to the "Note - Notes" section of the destinations selected during application.
- **30 points** for **professional experience** in Italy or abroad and any other experiences in **associations, sports and culture**. Students should add these points to the "Note - Notes" section of the destinations selected during application.

3. Application Annexes

Add any language certification to the **"Annex"** section.

4. Reallocating destinations

When **candidates result as eligible in the first final ranking, but not selected**, any available places will be reallocated by a public call. Candidates who are eligible but have not been selected will be invited according to their ranking to a **short face to face meeting** to choose between the remaining destinations. The time and date of the meeting will be published on the [Call page](#). Those candidates who are eligible but did not win a place in the first ranking and who do not respond to the public call and as a consequence do not come to the meeting, will be automatically and **officially excluded** from the present Call.



1. How to apply

- Students from Scienze e tecniche erboristiche (Herbal Products) undergraduate degree programme can apply as UG;
- First-, second- and third-year students of the 5-year postgraduate degree program in Farmacia (Pharmacy) and Chimica e tecnologie farmaceutiche (Drug Chemistry and Technology) will have to apply as UG;
- Fourth- and fifth-year students of the 5-year postgraduate degree program in Farmacia (Pharmacy) and Chimica e tecnologie farmaceutiche (Drug Chemistry and Technology) will have to apply as PG, if they are interested in Mobility for thesis/internship;
- Fourth- and fifth-year students of *the* 5-year postgraduate degree program in Farmacia (Pharmacy) and Chimica e tecnologie farmaceutiche (Drug Chemistry and Technology) can apply as UG or PG, if they are interested in Mobility for courses and exams;
- PhD students and specialization course in Farmacia ospedaliera (Hospital Pharmacy) students will have to apply as D.

Candidates must indicate in the “Note” section of every destination chosen the following:

1. Motivation;
2. Language certificates, that must be attached to the application and cannot be older than 3 years

Candidates should also indicate the following in the "Dichiarazioni aggiuntive - Additional Declarations" section of their application:

3. Any previous Erasmus+ experiences;
4. Eventual participation in University organisation as student representatives.

Students should contact their [Degree programme International Mobility co-ordinator](#) before applying so as to have useful information on available destinations and opportunities.

If students have any questions about how to apply, they can also contact students' Tutor Arianna Niccolai (arianna.niccolai112@edu.unito.it) and the Department Erasmus+ Desk erasmus.farmacia@unito.it.

Before applying, candidates must also check the types of Mobility available at each destination by consulting the "Note - Notes" field. Students can, in fact, do their Erasmus+ Mobility based on course attendance, internship and/or experimental thesis, although they should also be aware that not all these three opportunities are necessarily all available in all destinations.

If a destination “Note - Notes” field indicates priority given to or reserved for experimental thesis, students who apply with this motivation will have priority.



Please note that students must have an adequate knowledge of the host country's language and/or English if they want to do a hospital internship. Students should check each destination's language requirements as some destinations also require a language certification.

Students should give a second and third choice of destination in their application.

2. Extra points

A max of 30 points will be awarded for:

- **Up to 15 points for motivation and personal Degree programme consistency** with the Mobility programme. Students are reminded that the extra points available for their motivation for experimental thesis will only be assigned to those who have made agreements with their thesis supervisor, who will introduce students to thesis labs once they have checked the relevance of the candidate's training path with the lab's research activities.
This thesis supervisor's consent must be demonstrated by attaching an e-mail from them to the application. If the supervisor does not give their consent, the student cannot carry out their thesis activities in the labs mentioned above. In this case, the student is not excluded from Erasmus +Mobility for Studies, but they will not receive the extra score for motivation. They should find a suitable laboratory where they can do their thesis research independently;
- **Up to 10 POINTS for language skills** (host country language for courses and host country language and/or English for thesis and internships). These skills must be certified and the certificate must not be dated more than 3 years before applying;
- **Up to 4 points** for previous **Erasmus+** experiences;
- **1 point** for being representatives in Collegial Bodies.

Extra-points for first-year students of 5-year Postgraduate Degree Program in Farmacia (Pharmacy) and Chimica e tecnologie farmaceutiche (Drug Chemistry and Technology) will be based on 100 points and assigned as follows:

- **up to 75 POINTS** in proportion to the result obtained in student's course entry test (TOLC). If a student did not take the TOLC because they were exempt, the qualification score that led to the exemption will count;
- **Up to 15 POINTS for motivation and coherence of student's own Degree programme** with coursework planned during Mobility;
- **Up to 10 POINTS for language skills** (host country language and/or English). These skills must be certified and the certificate cannot be more than 3 years old before applying.

Extra-Points for first year students enrolled in Scienze e tecniche erboristiche (Herbal Products) Undergraduate Degree Programme will be based on 100 points and assigned as follows:



- **up to 75 POINTS** in proportion to the result obtained in TARM or Course entry test (TOLC). If a student did not take the TOLC because they were exempt, the qualification score that led to the exemption will count.
- **Up to 15 POINTS** for **motivation** and **coherence of student's own Degree programme** with coursework planned during Mobility;
- **Up to 10 POINTS** for **language skills** (host country language and/or English). These skills must be certified, and the certificate cannot be more than 3 years old before applying;

D places will be assigned to PhD students according to how relevant their studies are to the experience offered by the chosen destination. The Department's Mobility Agreement Coordinator/Tutor must confirm and approve the relevance in writing which must then be attached to the application.

3. Reallocating

The type of reallocating chosen is by single ranking.

4. Erasmus+ meetings (in Italian only)

On **22nd November at 1.00 pm** in AULA F, Department Professors overseeing the agreements will describe destinations for **experimental thesis**.

All School of Agriculture and Veterinary Medicine (SAMEV) students regularly enrolled in a degree programme or in a PhD can apply for the Erasmus+ Mobility for studies.

1. Destinations

When applying, the student may indicate up to 3 alternative destinations, not necessarily belonging to the same language area.

1.1. Reserved Destinations

Students must check the "Note - Notes" field of each destination published for a.y. 2024/25 on the UniTo website to find out whether the destination is reserved, recommended and/or gives priority to specific Degree and/or structured Mobility Programmes. It should also be noted that students who choose a destination reserved for a degree programme other than their own will be excluded from that destination.

2. Additional score

The SAMEV School Commission for International Mobility assigns up to 100 extra points for first year Undergraduate or 5-year Postgraduate degree programme students and up to 30 points for all the other students based on their language skills either certified or declared in their applications. Motivation for a Mobility scholarship is also assessed based on the logic and completeness of the information provided. Applicants may attach any language certificates of the language of the study programme in the respective destinations, and/or of the English language.

3. Reassignment procedure - Second ranking

The reallocation of any available places to eligible candidates in the first ranking, but not successful mobility applicants, will take place by means of a single ranking through automatic assignment on the basis of areas and language requirements, taking into account the student's destinations.

4. Causes of exclusion

It is the responsibility of the candidate to check the list of active destinations published on the University portal and to verify the following:

- any restrictions indicated in the "Notes" field of the destination (e.g. further destinations reserved and/or with priority assignment to certain courses of study, double degree mobility, etc.)
- for DISAFA students: that the chosen destination provides places for the level corresponding to the course of study in which they are enrolled (UG: Bachelor's degree; PG: Master's degree; D: PhD);
- that the scientific-disciplinary area of the exchange (ISCED code) is compatible with one's course of study;
- that they meet the linguistic requirements of their chosen destination.



Students therefore will be considered EXCLUDED in the first ranking for the chosen destination if:

- they choose a destination reserved for a course of study other than their own;
- for DISAFA students: they choose a destination that does not provide places for their own level (e.g. PG student selecting a UG destination).

Students may be EXCLUDED in the first ranking if they choose a destination

- whose language requirements are not met;
- whose ISCED area is not compatible with their course of study.

ATTENTION: students in their third year of a Bachelor's degree (UG) who plan to graduate before departure and intend to undertake mobility during their Master's degree (PG) must choose a PG destination. If successful, they will only be able to leave for a PG destination if they have obtained their Bachelor's degree in the meantime and have duly enrolled in a Master's degree course.

5. Additional Departmental Contributions.

Department of Agricultural, Forest and Food Sciences:

The Department of Agricultural, Forest and Food Sciences allocates an additional contribution for the integration of the scholarships paid to Erasmus+ students for study in the academic year 2024/2025 enrolled in the Department's degree courses.

Payment modalities and grant amounts will be communicated at a later stage and subject to the availability of funds by the Department.

Department of Veterinary Sciences:

The Department of Veterinary Sciences undertakes to allocate an additional contribution of € 10,000 to supplement the scholarships paid to Erasmus+ students enrolled in a.y.2024/2025 Department degree courses.

The grant is intended for students who, on return, will have a coefficient of credits passed/month equal to 6 CFU/month (where CFU means credits registered in the UniTo career upon return from mobility). Should the budget made available by the Department not be sufficient to cover all requests, the Department's Erasmus Commission will proceed to draw up a ranking based on (in order):

1. credits passed in mobility in relation to the number of mobility months;
2. weighted average of the examinations recorded in the career for international mobility;
3. ISEE/ISSE parity/PPP per capita GDP;
4. age, with priority given to younger applicants.

The contribution may not exceed 120 euros/month and up to a maximum of 6 monthly payments. The contribution will be determined and paid to individuals only after the return of all students, **presumably in November 2025**.

Students interested in applying for the additional contribution must, at the end of the mobility period and after having obtained the official registration of the credits in their career, fill in the application form **no later than 30 November 2025**, which will be available, together with instructions on how to submit it, on the Erasmus+ page of the Department of Veterinary Sciences.



6. Specific departmental procedures for successful students

Winning Erasmus students are required to complete the online Learning Agreement with the International Mobility Commission and the Erasmus Coordinator and/or lecturers at the host university, and to assess the compatibility of the programmes followed abroad with the programme of the courses for which recognition will be requested.

In this regard, successful students are invited to consult the website of the destination university, in order to check the language requirements for the activities they plan to carry out, and to assess the compatibility of their own study plan with the courses taken abroad.

Department of Agricultural, Forest and Food Sciences

For the didactic organisation of the Erasmus+ period, the successful student/s must:

BEFORE DEPARTURE (April)

1. Contact the Disafa referent teacher of the location for which they won the grant and prepare the PSI (Individual Study Plan) proposal, according to the Department model provided by the Erasmus Commission - and available on the DISAFA website page "Internationality - Erasmus+ - Erasmus for study";
2. Attach to the PSI proposal the programmes of the courses they intend to follow abroad (languages allowed: Italian, English, Spanish or French);
3. Submit all the documentation to the DISAFA Erasmus+ Commission by 10th May for departure planned between 1st July and 31st December; by 15th October for departure planned between 1st January and 30th June.

PLEASE NOTE: some foreign universities require the completion of the Application Form by the summer before the beginning of the academic year. In this case, it is necessary to anticipate the submission of the PSI proposal as much as possible, even for those who intend to depart in the second semester.

APPROVAL (May for those starting in **the first semester**, **November** for those starting in the **second semester**)

1. The Erasmus Commission will examine the PSI proposal and send it to the Careers Commission (of the respective Degree Course), which will provide the indications for the necessary approval. On receipt of the approved PSI (which explicitly indicates which compulsory disciplines in the official study plan must be eliminated and replaced by those to be taken at the foreign institution), the Student Registry Office inserts the Individual Study Plan in the student's career.
2. After approval, the student completes the Learning Agreement (LA) through the UniTo online procedure, indicating all the exams and activities approved in the PSI proposal (under "Before the Mobility"), and sends it to the President of the Erasmus+ DISAFA Commission (ezio.portis@unito.it) for final verification.
3. The approved LA, signed only through the UniTo online procedure by the President of the Erasmus Commission must be sent by the student to the foreign institution before departure, and a copy to the UNITA and International Mobility Section (internationalexchange@unito.it).



VARIATIONS MADE NECESSARY ABROAD

1. If it becomes necessary to change the LA after starting the stay abroad the student makes the changes by accessing the UniTo online procedure again and indicating them in the form under "During the Mobility" and sends it to the President of the Erasmus Commission for approval and signature. Changes must be made only after consulting the Italian referent teacher of the host institution.
2. At the same time as the changes are made, the student completes a new PSI proposal and sends it by e-mail to the referent teacher of the host institution and to the President of the Erasmus Commission for approval. The processing time is 1 month or more, depending on the calendar of meetings of the Career Commissions.

RETURN OF THE STUDENT

1. On returning to Italy, the student submits to the UNITA and International Mobility Section the attendance certificate and the Transcript of Records (ToR - certificate of examinations taken) and fills in the FORM FOR RECOGNITION OF TRAINING ACTIVITIES CARRIED OUT IN ERASMUS+ AND INTERNATIONAL MOBILITY in which he/she indicates the examinations taken for which he/she requires recognition.
N.B. Some institutions send the ToR directly to the UNITA and International Mobility Section.
2. The Departmental Erasmus Commission completes the "RECOGNITION FORM" using the grade conversion table and sends it to the Student Registry Office, which records the exams taken and reinserts the exams not taken in the career plan.

Department of Veterinary Sciences

For the didactic organisation of the Erasmus + period, the successful student/s must:

1. fill in the form with the proposed study plan to be carried out during mobility, according to the Department template provided by the Erasmus Commission and available on the DSV website page under Internationality - Erasmus+ - Erasmus for study;
2. send the proposal to the DSV referent teacher of the foreign location;
3. once the study plan has been agreed, fill in the Online Learning Agreement (OLA) on my.unito.it, adding the courses agreed with the DSV referent teacher of the foreign location and the respective recognised courses;
4. the OLA will be checked and approved by the Degree Programme Coordinator (Responsabile Didattico per la Mobilità Internazionale del Corso di Studi).

Erasmus+ scholarship winners who intend to undertake a internship period abroad may do so, subject to the agreement defined in the Learning Agreement as follows:

- **CLS Veterinary Medicine students** - V.O. (previous qualification before D.M. 509/99): practical activities only if in Groups I and II clinical internship and Group II non-clinical internship (zoo-technical disciplines; no inspection);
- **CLS Veterinary Medicine students** - N.O. (students enrolled before 2016): practical activities in clinical fields during the entire internship (14 credits - 350 hours) and internship 16 credits (zoo-technical disciplines; infectious and parasitic diseases; pathological anatomy);
- **CLS Veterinary Medicine students** - N.O. (students enrolled since 2016): practical activities in clinical fields during internships (max 15 credits, including 9 credits on pets and 6 credits



of livestock), respecting the portfolio skills, coursework and preparatory skills. Students can also carry out practical activities in the field of animal husbandry and cadaver diagnostics, provided they respect the portfolio skills, coursework and preparatory skills;

- **CLM Veterinary Medicine** - N.O. students (pre-2016 cohorts - old organisation of the practical traineeship): practical activity in the clinical field of the entire practical traineeship (14 CFU - 350 hours) and the 16 CFU practical traineeship (zootechnical disciplines; infectious and parasitic diseases; pathological anatomy);
- **CLM Veterinary Medicine** - N.O. students (new organisation of placements from the 2016 cohort onwards): practical activities in the clinical field of placements (for a maximum of 15 CFU, of which 9 on pet animals and 6 on farm animals), in compliance with the portfolio competences and training projects and preparation work. It is also possible to carry out practical activities in the field of zootechnics and cadaveric diagnostics, again in compliance with the competences set out in the portfolio and training projects and propaedeutics.

Clinical internship credits that can be recognised correspond to:

- 2 credits internal clinical internship 3rd year;
- 5 credits internal clinical internship 4th year;
- 5 credits internal clinical internship 5th year (excluding skill lab and professional knowledge);
- 3 credits external internship 5th year on.



SME students can apply for any destination regardless of the Department they belong to, except for those destinations which have been reserved for students of specific degree programmes.

1. DEPARTURE CRITERIA AND CONDITIONS

Second and third year UG students can only apply if they registered the following credits before **31/10/2023**:

- Mathematics for Economics I (12 credits) and Microeconomics (12 credits) exams if enrolled in a Department of Economics, Social Studies, Applied Mathematics and Statistics (ESOMAS) Degree programme;
- 10 credits, if enrolled in a Department of Management “Valter Cantino” Degree programme.

First year UG students do **not** need a minimum total of credits in order to apply for the Call.

2. CHOOSING DESTINATIONS - UG/PG

Undergraduate students must apply for a destination where undergraduate places (UG) are available; postgraduate candidates must apply for a destination where postgraduate places (PG) are available; PhD candidates must apply for a destination where “D” places are available.

However, third year undergraduate students graduating before the winter session in December will be able to apply for a PG destination. In fact, if they win a scholarship, they can leave for the PG destination, but only once they have graduated. Departure is subject to students being enrolled in a School of Management and Economics postgraduate degree programme. Students should be aware that Erasmus+ student status and UniTo insurance are only guaranteed if they are enrolled in the postgraduate degree programme.

Students can apply for up to **two destinations**, even in different language areas. Students only interested in one destination can express their preference and, should the destination not be available, they will be admitted to clearing.

Applications will not be accepted for destinations where students do not meet the specific pre-requisites (i.e. language requirements, reserved destinations, double Degree programmes, etc). These students will be admitted to clearing, but as reserves.

3. DOUBLE DEGREE PROGRAMME DESTINATIONS

The School's [double degree](#) programmes are:

- Master in Business Administration: double degree with Université Côte d'Azur, Nice;
- Bachelor in Economia Aziendale in Cuneo: double degree with Université Côte d'Azur, Nice;
- Master in Economics and Management: double degree with Université Jean Moulin Lyon3;



- Master in Economics: double degree with Université de Rennes.

Candidates interested in double degree programmes must state their **first choice** of destination when applying to the Erasmus+ Call. Stating a double degree programme as a second choice will not be considered. Double degree programme candidates will have an interview in order to assess their language skills and suitability for the double degree programme. If a candidate is not considered eligible for the double degree programme after the interview, they will still be eligible for their second choice of destination, provided they have submitted the requested language proof in the application.

Interview dates will be published on the Erasmus+ Call webpage and those pages dedicated to the individual double degree programmes.

4. LANGUAGE REQUIREMENTS

For applications to be valid, candidates must fill in the “Additional Requirements” field proving they meet the language requirements of the University/ies they want to apply to. Students should remember they need a CEFR B2 level to successfully complete university courses. Here is the list of the main types of language requirements:

- I. **“No language requirements”** means candidates can apply regardless of their language level.
- II. The “Additional Requirements” field shows A SPECIFIC LANGUAGE LEVEL (eg. *French B1, English B2, English B2 AND German B1*, etc.) together with the wording **“students must provide proof of their language level or the Passaporto per l’Europa which is strongly advised before leaving”**:

➔ Students must attach the appropriate documentation during the application phase proving that their language level meets requirements (see points **a, b, c, d, e, f** of the following Article No. 5 “PROOF OF LANGUAGE SKILLS”). The hosting partner can request the scholarship winner to provide a language certificate during the application process. Students can enrol in a “Passaporto per l’Europa”* language test at the University Language Centre (Centro Linguistico di Ateneo, CLA) in order to obtain a CEFR language certificate.

Candidates are responsible for checking the hosting university’s language (and other) requirements **before applying** as they make the final decisions.

- III. The “Additional Requirements” field shows A SPECIFIC LANGUAGE LEVEL (eg. *French B1, English B2, English B2 AND German B1*, etc.) together with the wording **“Certificate to include in application”**:

➔ candidates **MUST include a certificate** that proves they meet the language level requirements (see points **b, c, f** of Art. 5 “PROVING LANGUAGE SKILLS”).

- IV. The “Additional Requirements” field shows the language level and **“certified”** (e.g. *“English B2 certified”*)

➔ the partner requires an INTERNATIONAL CERTIFICATION: (IELTS, DELF, DELE, etc.).

➔ the candidate **must** include a **certificate** with their **application** from among those listed in



the Additional Requirements field or specified on the partner university's website.

The “Additional Requirements” field can also show “Home Institution certification” which can only be issued when the candidate provides: self-certification of enrolment in a degree course held in English/*Passaporto per l’Europa* obtained previously/other valid international certificate among those recognised by the School.

***Passaporto per l’Europa:** Language certificate issued by [Centro Linguistico di Ateneo \(CLA\)](#) for Erasmus+ Call scholarship winners before their departure. This certificate is free and highly recommended for those who do not have a certificate issued by a language centre or international certificate (IELTS, TOEFL, DELF, etc). It must be submitted to the Partner University during application where requested.

5. PROOF OF LANGUAGE SKILLS

The application procedure includes candidates filling in a questionnaire declaring their language knowledge levels using the EU Framework of Reference for Language Skills ([CEFR](#)).

For each language spoken, students must prove their language skills by providing:

- Proof of having passed the university **language proficiency exam**. The documentation relating to the exam must be included in the application indicating the language, the date, the place and, if possible, the mark and credit value (***Students can download self-certification of exams from MyUniTo***).

Students should be aware that language exams only correspond to “**language skill proof**” **for the purposes of this Call**. Language teachers do not certify a student’s CEFR level as part of the partner university’s application process based on passing these exams. The only exception would be if the date of the test taken at CLA is after the application deadline.

As seen in Art 4. 11, the **candidate is responsible** for obtaining a language level certificate in time should the partner university require one. All scholarship winners are entitled to take the free “*Passaporto per l’Europa*” test at CLA.

The table below shows how the mark obtained equates to SME language course levels:

- b) An **international certificate** (IELTS, DELF DELE, DFP, BEC). Candidates must include the certificate showing the year it was awarded, the type of diploma and the mark (including any partial ones). See [here](#) for a list of certificates which SME School recognises.
- c) Other **language certificates or documentation suitable** for proving language level (e.g. Esabac, CLA or SAC certificate, *Passaporto per l'Europa*). Candidates must attach the documentation which indicates the year, the type and the mark (including any partial).
- d) **Transcript of Records (ToR)** relating to previous periods of mobility and proving that the candidate has passed language examinations.
- e) Self-certification of a candidate being **mothertongue or bilingual**, duly signed by the applicant. The Evaluation Committee reserves the right to interview the student in order to check the self-certified language level.
- f) Students applying to an English-speaking destination must provide self-certification of being enrolled in a degree programme held in English.

6. NON-EU DESTINATIONS

The same rules apply for EU destinations as for non-EU destinations.

Please note that ESOMAS students can only apply for non-EU destinations at PG level.

7. SAA SPECIFICS

Reserved Destinations

Business & Management (B&M), Information and Corporate Communication Management (MICA) and Business Administration (BA) first- and second year students can apply for exclusive destinations and some of which are specifically reserved for specific years (see "Notes" to individual agreements).

Choosing destinations

Students can apply for a maximum of two destinations, e.g. both European (which would entail two different languages and two separate tests) or a European destination and a non-European one (which would also entail two different languages and two separate tests).

SAC Certificate (SELF ACCESS CENTRE)

As mentioned in points 2 and 3 of the "LANGUAGE REQUIREMENTS" section above, SAA Campus students without a valid language certificate (not older than two years) can obtain the SAC Certificate proving their level.

8. EXTRA POINTS

The system automatically awards extra points from 0 to 30 to those with an eligible application based on their student record on **31/10/2023** and according to the following criteria:

- a weighted average under 26/30 (without rounding up), will be awarded 0 points;
- a weighted average of 26/30 to 27/30 (without rounding up) will be awarded 10 points;
- an average above 27/30 and up to 28/30 (without rounding up) will be awarded 20 points;



- an average above 28/30 (without rounding up) will be awarded 30 points.

The Commission will automatically award first year postgraduate candidates extra points from 0-30 following this criteria:

DEGREE MARKS:

< 90: 0 points

90-94: 5 points

95-99: 10 points

100-102: 15 points

103-106: 20 points

107-110: 25 points

Only for 110 with Honours: 30 points

9. CLEARING

Students who have won a scholarship but decide not to accept it, create an opportunity for other students who become eligible for that destination during the **clearing** process.

Eligible students (but not winners) on the first eligible candidate list or in clearing, will be eligible for the remaining vacant places. The Polo International Services office will invite these candidates to fill in a short questionnaire where they can indicate up to 10 preferences of destinations still available and based on their course (UG or PG). Students must check required language levels and/or certificates and select Partner Universities whose requirements they meet.

The remaining places will then be reallocated into a single ranking until there are no more places available, based on student scores, preferences and language skills declared in their application.

Candidates **who do not win a place on either destination** will be admitted to clearing, although on a reserve list.

10. COMMITTEE CHECKS

Any self-certification can be subject to Committee checks during the selection process, even in presence of the applicant. The Commission could, for example, invite the applicant to a short interview to double check their self-certified language level and motivation profiles. Students should also be aware of their legal responsibilities when making false declarations (penal code and special laws, in accordance with Art. 76 D.P.R. N. 445/2000).

1. Limitations and/or specific indicators for individual degree programmes

- **Year of enrolment**

First or sixth year students enrolled on any Single Cycle School of Medicine 5/6-year postgraduate degree programmes and those enrolled in the last year of any degree programme at the time of application are not eligible and so will automatically be excluded from the rankings, **except for:**

- Students enrolled in the 3rd year of a School of Medicine undergraduate degree programme, who expect to graduate before their departure and intend to enrol in a School of Medicine Master's degree programme in the a.y. 2024/2025. These students will have to choose a PG destination reserved to the degree programme in which they intend to enrol. The winners will be able to start their assigned mobility only if in the meantime they have graduated and have duly enrolled in the Master's degree programme for which the destination is reserved in the a.y. 2024/2025.

- **Type of enrolment**

Students enrolled outside the prescribed time for their degree programme (***fuori corso or ripetenti***) at the time of application for any degree programme are also not eligible and will automatically be excluded from the rankings.

- **Reserved destinations**

Students must apply for the destinations reserved for the course they are enrolled in. To check this, it is necessary to:

- [identify the Department to which your study programme belongs;](#)
- consult the ISCED and Notes fields among the destinations of the Department to which one belongs;
- check which degree levels are covered in the agreement (UG/PG/D).

Those who apply for destinations other than those reserved for the degree course they are enrolled in will be automatically excluded from those rankings.

NB:

- Students enrolled in the 6-year postgraduate degree programme in *Medicina e Chirurgia* (Torino) will have access to Department of Sciences of Public Health and Pediatrics (DSSPP) destinations.
- DSSPP destinations are not available for *Educazione Professionale* students.
- Department of Molecular Biotechnology and Health Sciences (DBMSS) destinations are not intended for *Bioteχνologie Mediche* students.
- PhD students can apply to their Department's agreements covering mobility of type D.

Students enrolled in *Infermieristica* - Department of Medical Sciences (Aosta Campus), in the absence of destinations reserved for them, will be automatically excluded from the first ranking. However, they will be able to compete in the second and final ranking for the destinations remaining vacant among those reserved for students of *Infermieristica* - Department of Sciences of Public Health and Pediatrics.

2. Extra Points

- **Extra points based on enrolment year** (max 6 points) *only for 6-year postgraduate degree programmes*: a bonus score will be assigned according to the year the student is enrolled in at the time of application, i.e.:
 - 2 points if enrolled in 3rd year;
 - 4 points if enrolled in 4th year;
 - 6 points if enrolled in 5th year.
- **Language skills (max 24 points)**. Candidates will be assigned a maximum of 24 points for each destination chosen based on their language skills (see *Requisiti Linguistici* for each agreement), according to the following criteria:



- 0 points if the candidate does not present a certificate or a certificate which is not consistent with the language used in the chosen destinations or a certificate which the Committee deems unsuitable;
- 10 points for language certifications consistent with the language of the course, but showing a lower level of knowledge than indicated;
- 24 points for certificates consistent with the language used in the chosen destination's courses and with the skills level indicated, where specified in the agreement.

Points will be awarded for language skills **certified by formal certificates of the language level achieved** (according to the Common European Framework of Reference for Languages - CEFR), attached when completing the application.

For each destination, the language certificate submitted in the application with the highest score will be assessed, in line with what is indicated in the *Requisiti Linguistici* field.

Students can certify language skills via:

- international certificates validated by AICLU. See the list here:
<https://www.cla.unito.it/it/valutazione-linguistica-e-certificazioni/certificazioni-validate-dall-aiclu>;
- international certificates issued by the University Language Centre CLA-UniTo;
- secondary education diploma indicating a medium of instruction other than Italian and consistent with the language requirement to be certified for the destination; this type of certificate will be considered equal to language level B2, based on CEFR;
- enrolled in a course held in English if this is the language to be certified; this type of certificate will be considered equal to language level B2, based on CEFR;
- any other language certificates based on CEFR, which are not validated by AICLU, must be assessed by the Committee for their eligibility during the selection process.

Winners might randomly be required to submit the original of the language certificate they attached to the application, within 10 days after the deadline for accepting the scholarship. Failure to provide this document will result in automatic exclusion from the rankings.

Students are responsible for checking what host universities' language requirements are by consulting the respective websites and UniTo portal in the active destinations section. Scholarship winners who do not have language certificates required by the host university at the time of applying, are still required to provide them within the time frame indicated.



3. Rankings and Reallocations

- **Reallocations**

Reallocations will be carried out by single ranking (highest score).

- **Previous Erasmus+ for studies experiences**

Students who have never benefited from an Erasmus+ mobility for studies grant will be given priority in this Call. Consequently, the following cases will not qualify in the first final ranking:

- students who have already completed an Erasmus+ mobility for studies either in-person or online during their current degree programme;
- Erasmus+ Mobility for studies grant winners for a.y. 2023/2024, who did not renounce or receive notice of cancellation of mobility from their chosen Host University.

Students who have already enjoyed their mobility, including online, can participate in the reallocation phase when some destinations are still available. This will be based on the grade they obtained for academic merit and extra points as specified above.

Applicants must indicate any previous Erasmus+ mobility for studies, specifying the year, duration and destination in the **“Dichiarazioni aggiuntive” (Additional Declarations)** field of the application; similarly, in order to facilitate the Committee’s work, students should indicate if they accepted an Erasmus+ for studies grant for a.y. 2023/2024; or if they renounced or received notice of cancellation of mobility from their chosen Host University for Erasmus+ for studies mobility grants.

4. School of Medicine further guidelines

- Before leaving, students must arrange the Learning Agreement with their degree programme International Mobility coordinator in order to check:
 - compatibility between the programmes abroad and the student’s degree programme at UniTo which have to be eligible for recognition;
 - compatibility of credit value (+/-20%) to acquire during the mobility with those acquired during the UniTo degree programme and which must be eligible for recognition, in compliance with the Guidelines for recognising coursework abroad.
- The training activities envisaged during the Erasmus+ mobility period must be indicated in the Learning Agreement in compliance with any special requirements of the cohort to which they belong; they must not involve the recognition of courses scheduled in the UniTo study plan in previous years; they can correspond to courses scheduled in one's study plan in the year of enrolment at UniTo during the mobility period or in the year immediately following.



-
- If a course in Italy is divided over two years (eligibility + exam) but is offered by the Host University in just one year, the degree program International Mobility Coordinator is responsible for deciding whether or not to accept it on the basis of credits and course programme and the Learning Agreement.
 - Degree programme internships scheduled for the student's year abroad and not done abroad must be completed according to methods defined with the Degree programme International Mobility Co-ordinator and in a agreement with the relevant academic offices.

1.1. From 2nd year undergraduate degree students onwards, 2nd year 5/6-year postgraduate degree students onwards, postgraduate degree and PhD students will be awarded up to 30 points based on:

These skills must be documented, i.e.:

- Students with international **certificates**: indicate the type, grade obtained and date issued and **attach a copy to the application**;
- Study/work/stay abroad: indicate dates, periods, reasons;
- Number of **years** student has **studied** the language/**exams** taken, etc. (indicate dates, periods...).

PLEASE NOTE: Mother tongue students of the host country’s language can self-certify their language skills in the "Note - Notes" field of their application. However, students should check that language self- certification would be accepted by their chosen destination. Should the Host Institution require a language certificate, even mother tongue applicants might be required to obtain a certificate from the Host University. Students should therefore check the chosen destination’s agreement and/or ask the agreement coordinator for clarification.

2.2. Motivation – “Dichiarazioni aggiuntive - Additional declarations” in the application

Candidates must specify the following in the "Dichiarazioni aggiuntive - Additional Declarations" field of their application and give an accurate description of their motivation, i.e.:

- Contents must be detailed, complete and logical;
- **Objectives set** and **training activities** that they intend to do abroad (e.g. courses, exams, thesis research) must be outlined;
- Naming at least two **courses** offered by the student’s first destination and their corresponding UniTo courses which will be validated on return from Mobility;
- It is worth highlighting the **compatibility** of the foreign course programs with the UniTo course program the student is enrolled on;
- Students should also highlight the **consistency** between the host coursework and their own university program. In fact, **priority** will be given to students who choose destinations which their own Department recommends.



Students are therefore advised to **consult** the University's website and **programmes of each destination**.

Legal responsibilities apply relating to **false declarations** (see Criminal Code and special laws on the subject, as per Art. 76 D.P.R. No. 445/2000) and students should be aware that the Selection Commission might **check** any self-certifications at any time.

3. "Allegati - Attachments" field in the application

Students should attach a copy of their language certificates in the "Allegati - Attachments" field.

4. Reserved destinations

Students must check the "Note - Notes" field of each destination published for a.y. 2024/25 on the UniTo website to find out whether the destination is reserved and/or gives priority to specific Degree and/or structured Mobility Programmes. It should also be noted that students who choose a destination reserved for a degree programme other than their own will be excluded from that destination.

5. Special cases

The following degree programme list shows the special cases when applying for the Erasmus+ Call for studies:

Please note that students from courses outside the School of Nature Sciences who apply for a destination from one of the School's Departments will only be able to choose the other two destinations within the School of Science itself and will not be able to choose these destinations from another School or Department.

6. Reallocating destinations – Second ranking (so-called ultimate ranking)

Students who are eligible, but not selected for the scholarship, will be automatically reallocated on the remaining destinations based on language areas and requirements, taking the student's first destination choice into account.

7. Reasons for exclusion

Candidates must consult the **destinations** list published on the [UniTo website](#) and **check** the following:

- any **restrictions** in the "Note - Notes" field of the destinations (e.g. additional **destinations reserved** and/or priority for certain study programmes – mobility for double degrees, etc.);
- that the destination chosen includes places for the **level** corresponding to the student's Degree programme (UG: undergraduate degree; PG: postgraduate degree; D: PhD);
- that the scientific-disciplinary area abroad (**ISCED** code) is compatible with the student's degree programme;
- they meet the chosen destination's language **requirements**.

Students will be considered **EXCLUDED** from the ranking list, if they:

- choose a destination **reserved** for a Degree programme other than their own;
- choose a destination which has no places at their level (e.g. *PG student who chooses an UG destination*).

Students can be considered **EXCLUDED** from the first ranking list if they choose a destination and:

- they do not satisfy language requirements;
- the ISCED area is not compatible with their studies;

PLEASE NOTE: Third year undergraduate degree (UG) students planning to **graduate before departure** and intending to be on their Mobility programme during their postgraduate degree (PG) will have to **choose a PG destination**. Scholarship winners can only leave for the PG destination if they have since graduated and enrolled for a.y. 2024/2025 in a postgraduate degree



programme.

8. Department extra-funding

8.1. Department of Computer Science

The Department of Computer Science allocates extra funding of €10,000 in scholarships paid to Erasmus+ for Studies students of academic year 2024/2025 enrolled in the Department's Degree programmes.

This funding is **only** for students enrolled in:

- L-31, D.M. 270 - *Informatica* (Computer Science and Technology)
- LM-18, D.M. 270 – *Informatica* (Computer Science)
- 26, D.M. 509 – *Informatica* (Computer Science) PG courses in:
 - 23/S, D.M. 509 – *Logica computazionale* (Computational Logic)
 - 23/S, D.M. 509 – *Metodologie e sistemi informatici* (Methodologies and Computer Systems)
 - 23/S, D.M. 509 – *Realtà virtuale e multimedia* (Virtual Reality and Multimedia)
 - 23/S, D.M. 509 – *Sistemi per il trattamento dell'informazione* (Information Processing Systems)

This funding will be allocated according to the following criteria:

- this funding is reserved for students with a coefficient of validated credits/month equal to or more than 3 credits/month on return from Mobility. This refers to credits registered in their UniTo student profile on return from Mobility;
- total funding will be calculated based on the number of days the student actually took in the Mobility, considering a minimum threshold of 150 euros/month (i.e. for 30 days);
- funding will be paid by the end of the calendar year 2025, so Mobility credits must have been recognised by 31 October 2025;
- if the Department budget is not sufficient to cover all requests, a ranking list will be drawn up based on (in order):
 - a. weighted average of registered exams for international Mobility;
 - b. credits gained;
 - c. annual household income;
 - d. age, privileging the youngest candidates.

Students interested in extra funding must firstly have their credits recognised and then apply via the link below at the end of their Erasmus+ 2024/2025 Mobility: <http://di.unito.it/contributoaggiuntivoerasmus>. They must send it by October 31, 2025 to: commerasmccs@educ.di.unito.it.

The Computer Science Department International Mobility Committee will draw up a ranking list for those requesting extra funding.

8.2. Department of Physics

The Department of Physics allocates **€7,000.00** in extra funding for selected students enrolled in



one of the **Physics Department's Degree Programmes**.

This funding will be awarded to students whose **annual household income and/or benefits is less than €70,000** in proportion to the number of months spent abroad and the difference between €70,000 and the annual household income and/or benefits. For the purposes of this Call, the annual household income and/or benefits value corresponds to University student records for academic year 2023/24 based on 2023/24 Fees and Funding Regulations. Funding will not be awarded **if it is under €100** or over the threshold of €150 euros/month.

Students who want to apply for the funding must fill in the form before 01/11/24 which the Department office will send them in October 2024. The form including instructions will only be sent to selected students at their Institutional email address. Students can make amendments to their form but must complete the final version of the form by 09/10/2025, otherwise Department funding will not be paid.

The funding will also not be paid if the student has not passed at least one exam which is closely related to their own Degree programme disciplines. Funding will be determined and paid only once all students have returned from Mobility, presumably in **November 2025**.

8.3. Department of Earth Sciences

The Department of Earth Sciences allocates **€3,500** in additional funding to selected students enrolled in:

- Undergraduate Degree in **Geological Sciences** L-34 (*Scienze geologiche*);
- Postgraduate Degree in **Applied Geological Sciences** LM-74 (*Scienze geologiche applicate*);
- Postgraduate Degree in **Environmental Monitoring, Protection and Restoration** LM-75 (*Monitoraggio ambientale, tutela e ripristino*).

This funding will be awarded to students whose **annual household income and/or benefits is less than €70,000** in proportion to the number of months spent abroad and the difference between €70,000 and the annual household income and/or benefits. For the purposes of this Call, the annual household income and/or benefits value corresponds to University student records for academic year 2023/24 based on 2023/24 Fees and Funding Regulations.

Funding cannot exceed the threshold of **€150/month**.

If the Department budget is not sufficient to cover all requests, a ranking list will be drawn up based on (in order):

- a) **weighted average** of registered exams for international Mobility before 31/10/2025;
- b) **credits gained** and registered before 31/10/2025;
- c) **age**, privileging the youngest candidates.

Funding will be determined and paid only once all students have returned from Mobility, presumably in **November 2025**.

Erasmus+

Students interested in extra funding must firstly have their credits recognised once they come back and then fill in the request form. They must do this at the end of their Mobility program and before **30 November 2025**. The form and instructions will be available on the [Department of Earth Sciences' Erasmus page](#) as well as the Degree programme webpages from academic year 2024/25.



1. APPLICATION REQUIREMENTS

1.1. Department of Law, Department of Cultures, Politics and Society (CPS), Department of Economics and Statistics "Cognetti De Martiis", Interuniversity Department of Regional and Urban Studies and Planning and Strategic Sciences students can apply for School of Law, Politics and Social-Economic Sciences destinations.

1.2. Undergraduate students must apply for a destination where "UG" (undergraduate) places are available whereas Postgraduate students must apply for a destination where "PG" places are available (postgraduate); PhD students must apply for a destination where "D" places are available. Only 5 years postgraduate law students can apply for both UG and PG places.

1.3. Third year undergraduate students who will graduate before the winter session (December 2024) can apply for a PG destination and leave in the second semester a.y. 2024/2025. These students however will only actually be able to leave for the PG destination once they have graduated. Departure is subject to the student enrolling on the postgraduate degree programme. In fact, the student's Erasmus+ status and UniTo insurance are only guaranteed once they have enrolled on the School of Law, Politics and Social-Economic Sciences postgraduate degree program.

1.4. First year students of the 5 years postgraduate degree program in Law cannot apply for Erasmus+. The students of the Department of Law who want to apply for this call must be enrolled in one of the undergraduate or postgraduate degree programmes or at least in the second year of the 5 years postgraduate degree programme. The students of the 5 years postgraduate degree programme must have passed at least 4 exams of the first year at the moment of the application.

2. NON-EU DESTINATIONS FOR PG

The same rules apply for EU and non-EU destinations.

First and second year undergraduate and 5 years postgraduate degree programs cannot apply for non-EU destinations, since mobility is only available during the second (PG) cycle.

3. DESTINATIONS FOR OBTAINING A DOUBLE DEGREE QUALIFICATION (Law and CPS Departments)

Applicants interested in a double Degree qualification:

- for the Department of Law: Torino-Paris, Torino-Nice, Torino-Chambery, Torino-Fribourg;
- or the Department of Cultures, Politics and Society: Torino-Thessaloniki

must apply to the Erasmus+ Call and can express up to a maximum of two preferences. The choice of the double Degree destination, however, must be their **first choice** as their second choice will not be taken into consideration.

Only for the double degrees Torino-Paris and Torino-Nice it will be possible to indicate both programmes in order of preference.

Students must undergo an in-person interview to assess their language skills and suitability for the double Degree programme. If an applicant is not considered eligible for the double Degree



programme after the interview, they can try for the second destination in their application, for which they must have already provided the requested language certificates.

Interview dates will be published on the Erasmus+ Call page and on each page of the double degree programme.

4. APPLICATIONS

4.1. Students can choose up to **TWO destinations** to be evaluated for.

4.2. When choosing the destination, students must check if there are any restrictions in the “Notes” field (e.g. destinations reserved for double-degree programmes and EAP) and in the subject area (ISCED code), which refers to the disciplines scheduled. Code 0923 Social work and counselling is reserved for students enrolled in the "Social Work" undergraduate and postgraduate degree programmes, so all students should consult the destination university’s website to understand the compatibility of their own courses with those offered abroad.

4.3. Students should use the Notes field of each destination to outline the reasons for their choice of destination, e.g. consistency with their study plan, coursework and exams they are interested in taking during the Mobility (thesis research, internship, double qualification, etc.) or, where appropriate, other information deemed to be useful for the Commission. Students do not need to attach a letter of motivation to their application.

4.4. Students of the Department of Law who intend to obtain the NovJus diploma should note that it is possible to take one of the three courses included in the transdisciplinary training course during the mobility, choosing from the equivalent courses offered by the host University. Only after obtaining the diploma students will be entitled to receive a supplementary financial support (https://www.dg.unito.it/do/home.pl/View?doc=enziale/2023_2027/giurista_tomorrow_editore_formativa.html).

5. LANGUAGE SKILLS

5.1. The applicant must complete a questionnaire together with their application, declaring, or self-certifying, their language skills and level according to the CEFR framework: <https://www.coe.int/en/web/common-european-framework-reference-languages/table-2-cefr-3.3-common-reference-levels-self-assessment-grid>.

Students should look closely at the Partner Universities’ language requirements in the Notes, especially for documents required during application and/or before departure, in the absence of these documents, students will be considered ineligible.

5.2. Language skills must be shown by:

- a) passing university language exams, **indicating the year, where the student took the exam, grade and number of credits obtained.**
- b) holding international certificates, **attaching the certificate and indicating the year, type of diploma, grade obtained (specifying any partial exams).**

- c) self-certification of significant periods of study/stay abroad, number of years studying the language, attendance and/or passing of the *Lettorato* Test, self-certification downloadable from MyUnito, of enrolment in a degree programme taught in English, etc.

Even those who have undocumented language skills can self-certify their level of competence on the basis of the CEFR framework. C2 (advanced level) is the highest competence, corresponding to that of one's native language, A1 (basic level) is the lowest competence. Please read the CEFR framework for more details.



It is strongly recommended (**compulsory for students self-certificating a level C1 or C2**) to document your language skills listed under a,b,c by uploading the relevant attachment (e.g. language certificate, certificate of language courses, documentation of stays abroad, language grade or partial grade of university examination, self-certification of experiences carried out independently). A signed declaration by the lecturer is not required for the Lettorato Test.

6. EXTRA POINTS

Additional 0 to 30 points shall be attributed automatically according to the following criteria:

- Those who have submitted an application compliant with the Call and - **as of 31/10/2023** – whose weighted average is less than 26/30 (without rounding) will be awarded 0 points;
- those whose weighted average is between 26/30 and 27/30 (without rounding) will be awarded 10 points;
- those whose average is above 27/30 and up to 28/30 (without rounding) will be awarded 20 points;
- those whose average is above 28/30 (without rounding) will be awarded 30 points.

The Commission will award to the applicants enrolled in the first year of a postgraduate degree:

- 0 points: for scores lower than 90/110;
- 5 points: for scores from 90 to 94/110;
- 10 points: for scores from 95 to 99/110;
- 15 points: for scores from 100 to 102;
- 20 points: for scores from 103 to 106;
- 25 points: for scores from 107 to 110;
- 30 points: for the grade 110/110 with *lode*.

Linguistic knowledge will not be given a score but an eligibility assessment; if the student, therefore, does not meet the host university requirements, the application will be considered NOT eligible.

7. REALLOCATION

In the reallocation phase, following withdrawal or non-acceptance by the winner, the successful candidates will be placed on a ranking list.

Students eligible but not successful in the first ranking will participate in the allocation of the remaining spots.

They will be able to express their preferences for the remaining available destinations by filling in a short questionnaire. Once they have selected the Department and the study cycle, the student may indicate the destinations still available in order of preference. It is the student's responsibility to check the language level(s) and/or certificates that may be required and to select only those partner universities whose requirements they meet.

Each Department Commission oversees reallocation, considering the student's score, language areas and discipline consistency with the desired destinations.



8. COMMISSION CHECKS

Any self-certification can be subjected to Commission checks during the selection process, even in presence of the applicant. The Commission could, for example, invite the applicant to a short interview to double check their self-certified language level and motivation. Students should also be aware of their legal responsibilities when making false declarations (penal code and special laws on the subject, in accordance with Art. 76 D.P.R. nN. 445/2000).



1. Participation requirements

Students enrolled in following Departments can apply for the destinations offered by the School of Humanities:

- Humanities;
- Historical Studies;
- Philosophy and Educational Sciences.

Students enrolled in a three-year degree programme must apply for a destination where "UG" (undergraduate) places are available; students enrolled in a master's degree programme must apply for a destination where "PG" (postgraduate) places are available; students enrolled in a doctorate programme must apply for a destination where "D" places are available. Only single-cycle degree students can apply for both UG and PG places.

2. Non-EU PG destinations

To apply for non-EU destinations, the same rules are valid as for EU destinations.

3. Application

Students may indicate up to three destinations on which to be evaluated.

When choosing destinations, students must pay attention to any restrictions indicated in the Notes field (e.g. destinations reserved for double degree programmes) and to the area of the exchange (ISCED code, which refers to the intended subject area). It is recommended to consult the website of the destination university in order to assess the real compatibility of one's study plan with the programmes abroad. It is also advisable to consult the criteria followed for the recognition of the activities abroad (*Guidelines*).

Limitations and/or specific indications: check *reserved destinations* as may be indicated in the active destinations in the NOTES field of each exchange.

Reasons for the choice of destinations, e.g. consistency with study plan, courses you are interested in, envisaged activities during mobility (thesis research, internship, double degree, etc.) or any other information that could be useful and strategic for the Commission must be included in the Application Form in the "Notes" field of each destination.

Method of reassignment/re-allocation: ex officio by language area ranking.

Additional score will be assigned up to a maximum of 30 points using the following criteria:

- Language skills: up to 5 points;
- Motivation: up to 25 points.



Only for students enrolled in the first year of a undergraduated degree or a five-years degree will be awarded an additional score of up to 70 points, additional points will be awarded up to a maximum of 70 points based on the following criteria:

- Up to 30 points for motivation and goals;
- Up to 30 points for self-certified or certified language skills;
- Up to 10 points for student's professional or cultural experiences in Italy or abroad.

If the student declares specific language skills, he / she must attach a proper certificate in pdf format within the application form (certifications only, no self-declaration).

➤ **Department of Historical Studies**

1. Destinations for the attainment of Double Degree

Those interested in the Turin-Lyon double degree courses in History (UG) and Historical Sciences (PG) must apply through the Erasmus+ Call. The destination related to the double degree must be listed as first preference.

2. Additional Contribution

The Department of Historical Studies allocates an additional contribution quantified in €5,000 to integrate the scholarships provided to the students of the Department of Historical Studies for the Erasmus+ for Study Call of the academic year 2024/2025.

This additional contribution will be allocated according to the following criteria and modalities:

- the contribution is reserved for students belonging to the Department of Historical Studies;
- the contribution is intended for students who, upon their return, have sustained and recognized at least 4 CFUs per month (where CFUs are defined as credits validated by November 30, 2025 by UniTo offices in charge);
- the total contribution will be calculated on the number of days actually carried out during Mobility, and will be calculated considering a minimum monthly allowance of €100 (for 30 days) **and up to a maximum of €400** which is equal to 4 monthly payments – 120 days of Mobility actually carried out abroad;
- if the budget made available by the Department will not be sufficient to cover all the requests, the Department's Erasmus Commission will proceed to establish a ranking based on (in order):
 - credits passed in relation to the number of months in mobility;
 - ISEE;
 - age, with priority given to younger candidates.

Students interested in competing for the allocation of the additional contribution should make arrangements for the recognition of credits taken during the mobility **no later than Nov. 30, 2025**. The application form will be sent to those students who have completed the mobility and are eligible for the contribution according to the criteria described above.



SCHOOL OF INTER-DEPARTMENTAL STRATEGIC SCIENCES - SUISS

According to the latest individual agreements and/or this document, SUISS destinations are reserved for students enrolled in L/DS and LM/DS of the following degree courses:

- *L/DS SCIENZE STRATEGICHE E DELLA SICUREZZA;*
- *LM/DS SCIENZE STRATEGICHE.*

UG/PG level: students must consult the list of available affiliated locations and check that the destination they are interested in provides levels which correspond to their own Degree course (UG: Bachelor's Degree, PG: Master's Degree).

Other indications:

- the A WIENER04 destination is reserved exclusively for students with EU citizenship and is part of the specific programme.

The ERASMUS SUISS Commission will apply the following **criteria**, in the Extra Points framework (max 30 points):

- **up to 20** points for target language skills. Students must produce any certificates in their possession: skills and any valid certificates relating to local language (English all destinations);
- **up to 5** points for host country language skills. Students must produce any certificates in their possession: skills and any certificates related to the local language;
- **up to 5** points for motivation.

N.B. First year *SCIENZE STRATEGICHE* and *SCIENZE STRATEGICHE E DELLA SICUREZZA* Degree Course students can only take advantage of the extra points up to 60 points, obtained by doubling the grades attributable to the criteria above.

Any available places will automatically be reassigned based on a single eligible candidates list after eligible students (not winners) have expressed their preferences of destination. Places that are still free during reassignment can be assigned to SUISS students who are not in the eligible candidate list at SUISS's three Schools which is based on their priorities and subject to SUISS destinations accepting.
